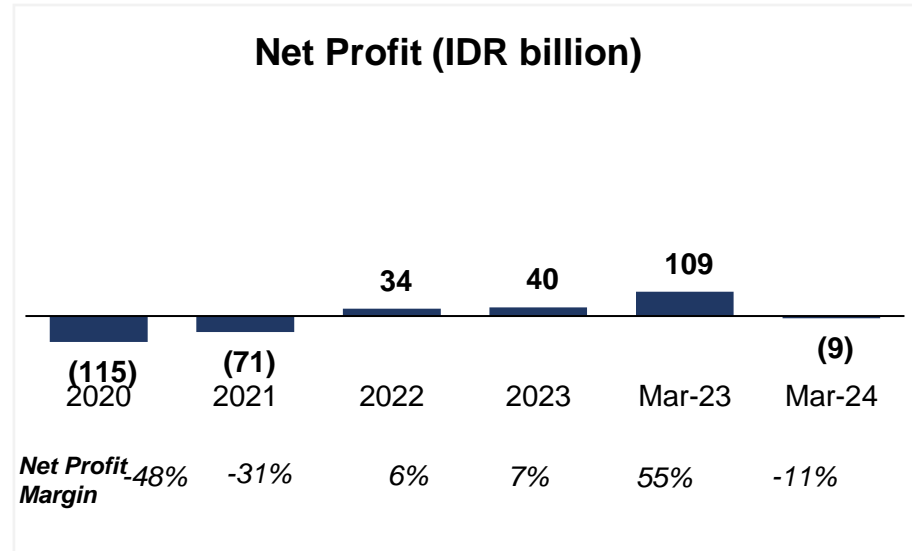
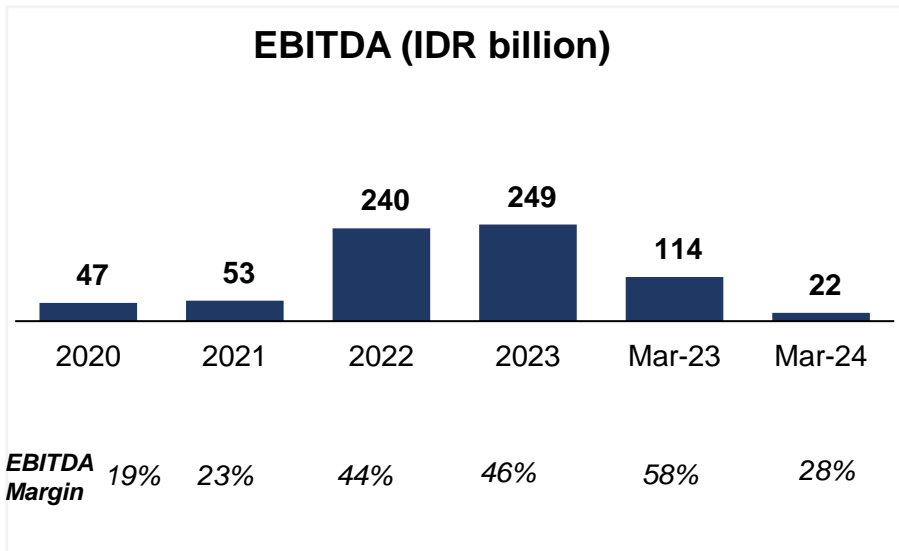

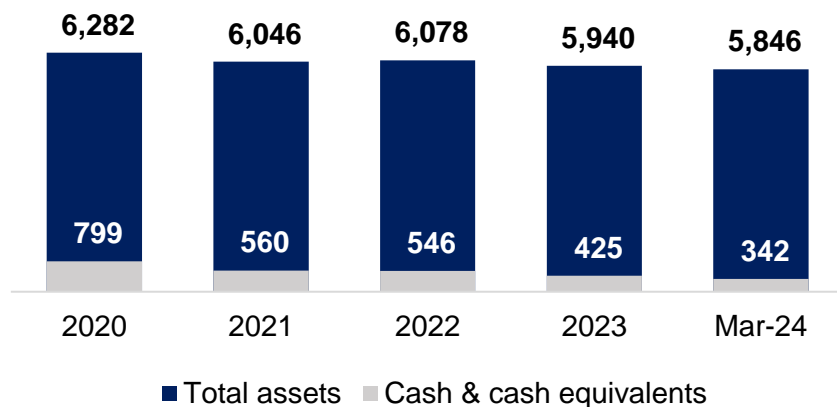
- ❑ In the first quarter of 2024, the Company sold 1 hectare to local cold storage and contractor companies.

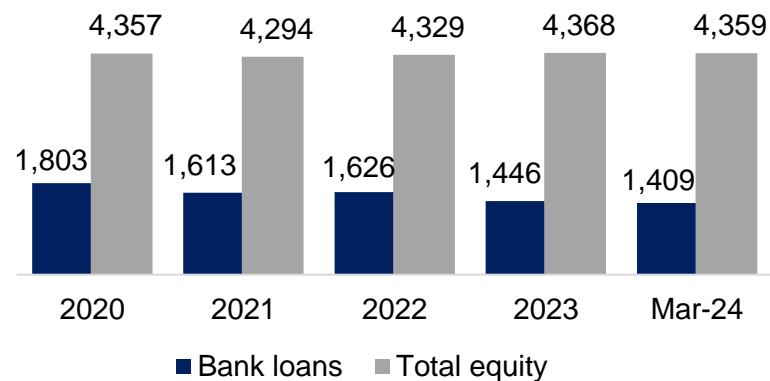


# Financial Position 31 March 2024

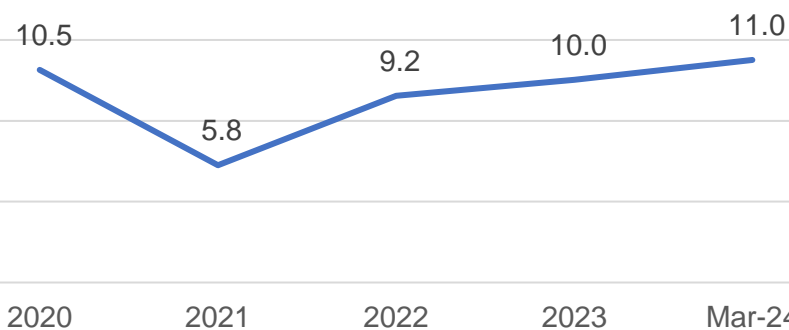
### Cash and Total Assets (IDR billion)



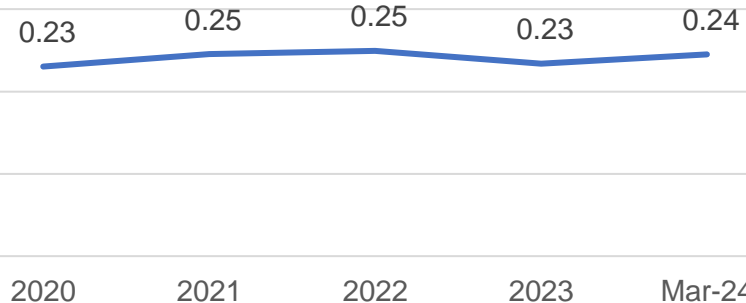
### Bank Loans and Total Equity (IDR Billion)
